REPORTS OF COMMITTEES

Senator Moe, R.D. moved that the Committee Report at the Desk be now adopted. The motion prevailed.

Senator Sams from the Committee on Health and Family Security, to which was referred

S.F. No. 887: A bill for an act relating to health; creating registration for medical response units; proposing coding for new law in Minnesota Statutes, chapter 144E.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [144E.275] [MEDICAL RESPONSE UNIT REGISTRATION.]

Subdivision 1. [DEFINITION.] For purposes of this section, the following definitions apply:

(a) "Medical response unit" means an organized service recognized by a local political subdivision whose primary responsibility is to respond to medical emergencies to provide initial medical care before the arrival of a licensed ambulance service.

(b) "Specialized medical response unit" means an organized service recognized by a board-approved authority other than a local political subdivision that responds to medical emergencies as needed or as required by local procedure or protocol.

Subd. 2. [REGISTRATION.] The board may establish registration for medical response units and specialized medical response units.

Subd. 3. [MEDICAL RESPONSE UNIT QUALIFICATIONS.] To be registered with the board, a medical response unit must:

(1) submit an application form prescribed by the board;

(2) have a medical director according to section 144E.265;

(3) be staffed by at least one first responder or one emergency medical technician, as appropriate to the level of care given;

(4) submit a letter from the appropriate municipality, township, or county governing body recognizing the medical response unit as the unit in its geographical area designated to respond to a medical emergency; and

(5) be dispatched to the scene of a medical emergency on a routine basis by a public safety answering point, as defined under section 403.02, subdivision 5, or an ambulance service.

Subd. 4. [SPECIALIZED MEDICAL RESPONSE UNIT QUALIFICATIONS.] To be registered with the board, a specialized medical response unit must:

(1) meet the qualifications described in subdivision 3, clauses (1) to (3); and

(2) submit documentation from a board-approved authority other than a local political subdivision recognizing the specialized medical response unit as a unit designated to respond to medical emergencies as needed or required by local procedure or protocol.

Subd. 5. [EXPIRATION.] The medical response unit registration expires two years from the date it is issued. The board may stagger expiration dates in order to be consistent with the provisions of Minnesota Rules, part 4690.7900.

Subd. 6. [RENEWAL.] The board may renew the registration of a medical response unit or specialized medical response unit upon:

(1) submission, before the registration expiration date, of a completed renewal application form as prescribed by the board;

(2) compliance with subdivision 3, clauses (2) to (5), for a medical response unit or compliance with subdivision 3, clauses (2) and (3), and subdivision 4, clause (2), for a specialized medical response unit; and

(3) the provision of any other information as requested by the board.

Sec. 2. Minnesota Statutes 2000, section 144E.29, is amended to read:

144E.29 [FEES.]

(a) The board shall charge the following fees:

(1) initial application for and renewal of an ambulance service license, \$150;

(2) each ambulance operated by a licensee, \$96. The licensee shall pay an additional \$96 fee for the full licensing period or \$4 per month for any fraction of the period for each ambulance added to the ambulance service during the licensing period;

(3) initial application for and renewal of approval for a training program, \$100; and

(4) duplicate of an original license, certification, or approval, \$25; and

(5) initial application for and renewal of a medical response unit and a specialized medical response unit registration, \$25. The board may prorate the initial registration fee based on the expiration date.

(b) With the exception of paragraph (a), clause (4), all fees are for a two-year period. All fees are nonrefundable.

(c) Fees collected by the board shall be deposited as nondedicated receipts in the general fund."

Delete the title and insert:

"A bill for an act relating to health; creating registration for medical response units; amending Minnesota Statutes 2000, section 144E.29; proposing coding for new law in Minnesota Statutes, chapter 144E."

And when so amended the bill do pass. Amendments adopted. Report adopted.

WHEREAS, 19 states, the United States of America, all of the Canadian Provinces, some of the American military forces, and several United States cities have adopted their own tartan which can be worn by anyone of any nationality, known as District Tartans; and

WHEREAS, Minnesota has a rich history of Scottish influence in the founding of towns, cities, and counties; and that history is reflected in place names and celebrations throughout Minnesota; and

WHEREAS, Minnesotans of Scottish and Scotch-Irish descent have shown leadership in the fields of science, industry, literature, politics, exploration, and conservation; and

WHEREAS, 14 Scottish organizations in Minnesota had input into the creation of the Minnesota Tartan and Minnesota Dress Tartan through the Minnesota Tartan Day Cooperative; and

WHEREAS, the colors chosen for the Minnesota Tartan were chosen to symbolize Minnesota: royal blue for the land of 10,000 lakes; green for the Norway pine and conservation of our forests and fields; black and white for the loon, our highways, wild rice, and snow; pink for the showy lady slipper and the heart of the people; yellow/gold for the yellow lady slipper, the colors of fall, maize, and the golden opportunities found in Minnesota; and

WHEREAS, the Scottish Tartan Authority requires legislative action by a state to register a tartan as a State Tartan; and

WHEREAS, the Minnesota Tartan Day Cooperative initiated the creation of the Minnesota

Tartan and the Minnesota Dress Tartan as gifts for all of the people of Minnesota to symbolize the nature, qualities, and beauty of Minnesota and as a symbol of all that weaves us together; NOW, THEREFORE,

BE IT RESOLVED by the Senate of the State of Minnesota that it adopts the designs submitted by the Minnesota Tartan Day Cooperative for the Minnesota Tartan and the Minnesota Dress Tartan as the official Minnesota Tartan.

BE IT FURTHER RESOLVED that the Secretary of the Senate is directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and that of the Chair of the Senate Rules and Administration Committee, and transmit it to the Minnesota Tartan Day Cooperative.
