#### Senator Bachmann introduced--

**S.F. No. 16:** A bill for an act relating to capital investment; appropriating money for construction of certain interchanges on marked Interstate Highway 35E; authorizing the issuance of state trunk highway bonds.

#### Senator Bachmann introduced--

**S.F. No. 17:** A bill for an act relating to local government; requiring a super majority vote by the county to transfer certain local assessment responsibilities; amending Minnesota Statutes 2004, section 273.055.

**S.F. No. 21:** A bill for an act proposing an amendment to the Minnesota Constitution, article IV, section 4; requiring special legislative election in certain situations.
