This bill removes this cap on notary fee charges and creates a new limit that would allow a \$5 charge for each notary service. This is a 500 percent increase in the permissible fee for notary services. I would support a more reasonable fee increase, but a 500 percent increase is too large and could adversely impact businesses and individuals who require notarization of documents.
