I have vetoed and am returning Chapter 121, Senate File 477, a bill establishing a new fee on paint sold in Minnesota. The bill is similar to the paint fee bill I vetoed last year.

Legislators and stakeholders worked to address the concerns I raised in the 2008 veto message. However, this bill still places a double burden on consumers for an identical purpose. For example, it is estimated that local governments currently spend approximately \$6 million per year for used paint collection and recycling. Since current local tax revenues are paying for this program, the legislation should include a clear and direct mechanism to reduce local tax collections that currently support local paint collection and recycling programs.

I would be willing to consider legislation that creates an industry-managed paint collection and recycling program as long as the program clearly demonstrates taxpayers will not be paying for the

same thing twice.

I have vetoed and am returning Senate File 489, Chapter 127, a bill relating to reverse mortgage loans.

The intention of this bill is to protect borrowers from predatory lending practices, and I share that goal. However, this legislation may trigger unintended consequences and increase costs to consumers.

Reverse mortgage loans are a financial tool to convert some or all of the equity in a home into cash without having to sell and move away from the home. While not right for everyone, it is important this product continues to be offered in Minnesota. This legislation could have the unintended consequence of causing mortgage bankers to refrain from offering reverse mortgage loans to consumers.

The suitability requirement imposed on the lender in this bill is poorly defined. I agree that any reverse mortgage must be appropriate for the consumer. The suitability criteria in the bill should be clear and specific. The standard set forth in this bill is vague and will spawn litigation. More effort should be made to clearly articulate a specific suitability standard.

I encourage the authors to develop legislation that protects consumers from predatory lending practices but does not limit the availability of this type of product in Minnesota.

I have vetoed and am returning Senate File 1331, Chapter 162, an omnibus elections bill. This bill makes a number of changes to existing election laws.

Election laws set forth rules relating to the fundamental right to vote and the government's administration of those rights. The details of these laws matter, and the manner in which they are adopted matters as well. Omnibus election bills making changes to our election process should be bipartisan. Unfortunately, this bill fails that test.

I am also opposed to the change in this bill moving the primary from September to August.

This bill included language seeking to clarify the limitations on exit pollsters, which has been the subject of court challenge. Although I have vetoed this bill on other grounds, it is my hope this matter can be resolved when the Legislature returns next session.

Election law reform is needed in Minnesota. My hope is that bipartisan legislation will be passed during next year's legislative session, in time for the 2010 general election.

I have vetoed and am returning Senate File 97, Chapter 166, a bill authorizing and regulating the medical use of marijuana.

While I am very sympathetic to those dealing with end-of-life illnesses and accompanying pain, I stand with law enforcement in opposition to this legislation. Marijuana poses serious public safety and health risks. Legalized medicinal use could serve to compound these problems.

The FDA has not approved and does not regulate the medical use of marijuana. This bill would allow marijuana to be produced and distributed for medical purposes without any federal oversight to insure the drug is being used safely and effectively. Additionally, the scientific studies available regarding the benefits and risks of the medical use of marijuana are insufficient.

I also note that neither the Minnesota Medical Association nor the American Medial Association have endorsed this legislation.

Please be advised that I have vetoed and am returning Chapter 164, Senate File 971, a bill that duplicates current law relating to school board policies prohibiting bullying, intimidation, violence, and pattern of harassment in schools.

Bullying is a serious issue that must be vigilantly monitored, prevented, and addressed by school administration and staff. Students should be able to attend school without fear of being bullied, intimidated, harassed, or subject to violence. A failure by school administration and staff to vigorously and forcefully respond to these behaviors is unacceptable.

I agree with the goal of the bill. However, that goal is already addressed by existing Minnesota laws. Minnesota Statutes 121A.0695 requires school districts to adopt written policies prohibiting bullying of any student in any form. In addition, Minnesota Statutes 121A.03 requires school districts to adopt a written policy prohibiting sexual, religious and racial harassment. That law also requires the policy to conform with the Minnesota Human Rights Act and requires school districts to post the policy and discuss it with students and employees.

The proposed legislation is duplicative of current law which directly and clearly prohibits bullying of any type against any student for any reason.

Nevertheless, to ensure schools remain safe for learning, I have instructed the Commissioner of Education to review the model policy required by Minnesota Statutes 121A.03 and to contact school districts to ensure they are meeting the requirements of Minnesota law relating to intimidation and bullying. In addition, the commissioner will encourage school districts to revisit the enforcement of these policies to protect students from bullying, intimidation, harassment, and violence.
