(c) Interested parties have 21 days after publication to comment on the proposed rules. After the Minnesota Insurance Marketplace has considered all comments, the Minnesota Insurance Marketplace shall publish notice in the State Register that the rules have been adopted and the rules shall take effect on publication.

(d) If the adopted rules are the same as the proposed rules, the notice shall state that the rules have been adopted as proposed and shall cite the prior publication. If the adopted rules differ from

the proposed rules, the portions of the adopted rules that differ from the proposed rules shall be included in the notice of adoption, together with a citation to the prior State Register that contained the notice of the proposed rules.

(e) The Minnesota Insurance Marketplace shall seek comments from the Department of Administration, Public Information Policy Analysis Division, before adopting any final rules involving the use or disclosure of not public data.

(f) By October 1, 2013, by January 15, 2014, and by May 1, 2014, the board shall submit a report to the majority leader of the senate, the speaker of the house of representatives, and the chairs of the committees in the senate and the house of representatives with primary jurisdiction over commerce, that lists and describes all rules promulgated under this subdivision.

Subd. 9. Rulemaking after the first year. Beginning one year after enactment, the board may adopt rules to implement any provisions in this chapter using the expedited rulemaking process in section 14.389."
