If such prior monthly fuel payments for the year in the aggregate exceed the amount due based on the annual calculation, the project owner shall credit the public utility for the excess paid. If the annual calculation of fuel costs due exceeds the prior monthly fuel payments for the year in the aggregate, the project owner shall be entitled to be paid for the deficiency with the next invoice to the public utility. The amendment shall be negotiated"

Page 3, line 27, after the comma, insert "beginning with 2012,"

Page 3, after line 33, insert:

"EFFECTIVE DATE. This section is effective the day following final enactment."
