# Senator Sparks from the Committee on Jobs, Agriculture and Rural Development, to which was referred

**S.F. No. 2917:** A bill for an act proposing an amendment to the Minnesota Constitution by adding a section to article I; establishing an inflation adjusted minimum wage.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. CONSTITUTIONAL AMENDMENT PROPOSED.

An amendment to the Minnesota Constitution is proposed to the people. If the amendment is adopted, a section shall be added to article I, to read:

Sec. 18. (a) Every employer must pay each employee wages at a rate of at least:

(1) \$9.50 per hour beginning January 1, 2015; and

(2) the rate established under paragraph (b) beginning January 1, 2017.

(b) Beginning January 1, 2017, and each subsequent year, the minimum wage in paragraph (a) is multiplied by the ratio of the annual implicit price deflator for government consumption expenditures and gross investment for state and local governments as prepared by the United States Department of Commerce for the most recently available year, to the 2013 implicit price deflator for government consumption expenditures and gross investment for state and local governments as prepared by the United States Department of Commerce.

(c) If the United State Department of Commerce does not prepare an implicit price deflator, the legislature may select and utilize a mechanism that produces a measure that most closely resembles the implicit price deflator.

(d) The legislature may provide by law for a higher minimum wage than required under this section.

#### Sec. 2. SUBMISSION TO VOTERS.

The proposed amendment must be submitted to the people at the 2014 general election. The question submitted must be:

"Shall the Minnesota Constitution be amended to establish a minimum wage at a rate of at least \$9.50 per hour that is increased each year by the rate of inflation?

Yes ...... No .....""

And when so amended the bill do pass and be re-referred to the Committee on Rules and Administration.
