## Senator Dibble from the Committee on Transportation, to which was referred

**S.F. No. 1395:** A bill for an act relating to transportation; authorizing roadside signage for automatic external defibrillators for qualifying locations; proposing coding for new law in Minnesota Statutes, chapter 160.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, after line 7, insert:

"(a) For purposes of this section, "public access automatic external defibrillator" has the meaning given in section 403.51, subdivision 1, paragraph (e)."

Page 1, line 9, delete "under section 403.51"

Page 1, line 15, delete everything after the period

Page 1, delete lines 16 to 19 and insert:

"(c) To qualify as a participant and request directional signage under this section, locations or businesses with an outdoor public access automatic external defibrillator must:

(1) follow all registration, notice, and inspection requirements provided in section 403.51;

(2) place the device in a recognizable and easily accessible location; and

(3) identify the device with conspicuous and visible signage on the premises.

(d) Within 180 days, or to the extent practicable within 60 days, of receiving a request from a qualified participant, the relevant road authority must determine a suitable location and appropriate number of signs under the requirements of this section to clearly identify the location and place appropriate signage at the location of the qualifying business or location. All costs associated with"

Page 1, line 20, after "participants" insert "to the relevant road authority"

Page 2, delete lines 1 to 3

Page 2, line 4, delete "the day following final enactment" and insert "October 1, 2025"

Page 2, line 15, after the period, insert "The commissioner must maintain publicly available information about outdoor public access external defibrillator signage and best practices on the department's website, including qualifications for a sign under Minnesota Statutes, section 160.802; appropriate wayfinding techniques; device registry information; and guidance for local road authorities on appropriate sign placement and context."

Amend the title as follows:

Page 1, line 2, after "for" insert "outdoor"

And when so amended the bill do pass and be re-referred to the Committee on State and Local Government. Amendments adopted. Report adopted.

(1) be 18 years of age or older;

(2) have been employed by the child care center for a minimum of 30 days; and

(3) have completed the training required under section 142B.65, including orientation training and the training required within the first 90 days of employment.

## EFFECTIVE DATE. This section is effective July 1, 2025."

Amend the title as follows:

Page 1, line 2, delete everything after the semicolon and insert "modifying staff distribution requirements for child care centers;"

Page 1, delete line 3

Amend the title numbers accordingly

BE IT RESOLVED, by the Senate of the State of Minnesota:

For the 2025 session of the 94th Legislature, the Secretary of the Senate shall provide each member of the Senate with a postal service budget not to exceed \$1,300 for calendar year 2025, except as provided in this resolution. The postal service budget provided in this resolution is available until December 31, 2025.

In addition to the postal service budget provided to each member of the Senate in this resolution, the postal service budget for the following members of the Senate may be increased by the amounts indicated:

(a) for each member named as chair of a standing committee in the Senate resolution designating committee assignments, an increase of \$400 for calendar year 2025, for the necessary business of the committee; and

(b) for the Senate Majority Leader and Senate Minority Leader, an increase of \$500 each for calendar year 2025.
