#### Senator Fateh from the Committee on Higher Education, to which was referred

**S.F. No. 1035:** A bill for an act relating to higher education; modifying provisions related to campus sexual misconduct; amending Minnesota Statutes 2024, section 135A.15, subdivisions 1a, 2a.

Reports the same back with the recommendation that the bill be amended as follows:

Page 3, lines 1 and 30, before "institution" insert "postsecondary"

Page 3, line 4, before "institution" insert "postsecondary"

Page 3, line 6, delete "either or both" and insert "any or all"

Page 3, line 7, delete "and"

Page 3, line 8, delete everything after the second "the" and insert "parties, alternative resolution options; and"

Page 3, after line 8, insert:

"(3) academic or residential supportive measures, as requested by the victim."

Supportive measures must be determined on a case-by-case basis and may include, but are not limited to, exam or assignment extensions, excused class absence, change in on-campus residence, or schedule changes.

(e) A postsecondary institution must allow the reporting and responding parties to present and review relevant testimony by parties and witnesses, and relevant evidence compiled in an investigative report."

Page 4, line 14, delete "<u>victim</u>" and insert "<u>reporting party</u>" and after "<u>investigation</u>" insert "<u>,</u> <u>except that a postsecondary institution may temporarily delay a campus proceeding if requested by</u> law enforcement and if the campus proceeding may impede a criminal investigation"

Page 4, line 17, delete "an" and insert "a postsecondary"

Page 4, line 20, delete "a neutral third party" and insert "an advisor"

Page 4, delete lines 22 and 23 and insert:

"(4) information related to character, including character witnesses, questions or evidence about the sexual behavior or sexual preferences of the reporting party, or mental health records must not be considered, except:

(i) information related to the sexual behavior of the reporting party may be considered if it substantiates that the misconduct may have occurred, and is deemed relevant by the decision maker;

(ii) mental health and medical information of the reporting party may be considered if a release is signed by the reporting party and nonrelevant information is redacted;

(iii) if a responding party is found responsible, a postsecondary institution may consider medical and mental health information to determine sanctions; and

(iv) questions and evidence regarding the sexual preferences or past sexual behavior of the reporting party may be considered if such evidence is offered to prove that someone other than the responding party committed the conduct alleged by the reporting party, or the evidence concerns specific incidents of the reporting party's prior sexual behavior with respect to the responding party and is offered to prove consent;"

# Senator Latz from the Committee on Judiciary and Public Safety, to which was referred

**S.F. No. 662:** A bill for an act relating to civil actions; establishing a civil cause of action for the nonconsensual removal of a condom; providing penalties; proposing coding for new law in Minnesota Statutes, chapter 604.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

# "Section 1. [604.33] CAUSE OF ACTION; NONCONSENSUAL REMOVAL OF A SEXUALLY PROTECTIVE DEVICE.

Subdivision 1. Definitions. (a) For purposes of this section, the following terms have the meanings given.

(b) "Intimate part" means the sexual organ, anus, groin, or buttocks of any person, or the breast of a female.

(c) "Sexually protective device" means an internal or external condom, spermicide, diaphragm, cervical cap, contraceptive sponge, dental dam, or any other physical barrier device intended to prevent pregnancy or sexually transmitted infection. Sexually protective device does not include an intrauterine device or any hormonal birth control method.

Subd. 2. Cause of action. A cause of action for nonconsensual removal of a sexually protective device exists against the following:

(1) a person who intentionally removed a sexually protective device and caused contact between the sexual organ from which the sexually protective device was removed and the intimate part of another person who did not consent to the removal of the sexually protective device; or

(2) a person who intentionally removed a sexually protective device from another person's sexual organ without the other person's consent and caused contact between the sexual organ from which the sexually protective device was removed and their own intimate part.

Subd. 3. **Damages.** The court may award the following damages to a prevailing plaintiff from a person found liable under subdivision 2:

(1) general and special damages, including damages for mental anguish;

(2) punitive damages;

(3) statutory damages in an amount up to \$10,000;

(4) injunctive relief and any other equitable relief the court deems just and appropriate; and

(5) costs, disbursements, and reasonable attorney fees.

Subd. 4. Confidentiality. The court shall allow confidential filings to protect the privacy of the plaintiff in cases filed under this section.

Subd. 5. Other laws and remedies. (a) The rights and remedies provided in this section are in addition to any other rights and remedies provided by law.

(b) Nothing in this section affects or modifies the rights and obligations under chapter 518A.

**EFFECTIVE DATE.** This section is effective August 1, 2025, and applies to causes of action accruing on or after that date."

#### Senator Cwodzinski from the Committee on Education Policy, to which was referred

**S.F. No. 1404:** A bill for an act relating to education; modifying American Indian mascot exemption requirements; establishing a process for schools to apply for mascot replacement assistance; appropriating money for mascot replacement assistance; amending Minnesota Statutes 2024, section 121A.041, subdivisions 2, 3.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2024, section 121A.041, subdivision 2, is amended to read:

Subd. 2. **Prohibition on American Indian mascots.** (a) Starting September 1, 2026, a public school may not have or adopt a name, symbol, or image that depicts or refers to an American Indian Tribe, individual, custom, or tradition to be used as a mascot, nickname, logo, letterhead, or team name of the school, district, or school within the district, unless the school has obtained an exemption under subdivision 3.

(b) The prohibition in paragraph (a) does not apply to a public school located within the reservation of a federally recognized Tribal Nation in Minnesota, where at least 95 percent of students meet the state definition of American Indian student.

(c) A school district with a prohibited American Indian mascot according to paragraph (a), that has not received an exemption according to subdivision 3, must report to the chairs and ranking minority members of the legislative committees having jurisdiction over kindergarten through grade 12 education policy and education finance by February 14, 2025, and again by February 1, 2026, on the district's progress to comply with this section; and the district must submit copies of the reports to the Legislative Reference Library. The reports must include the following:

(1) confirmation that the district has removed the American Indian mascot, nickname, logo, letterhead, or team name from the district website;

(2) confirmation that the board of the district has approved a new mascot, nickname, logo, letterhead, or team name;

(3) a summary of the district's progress on removing the American Indian mascot, nickname, logo, letterhead, or team name from uniforms, equipment, signs, elements of facilities, and other district items; and

(4) a summary of resources necessary to comply with the prohibition in paragraph (a) and the district's plan to raise and allocate any necessary funds.

# EFFECTIVE DATE. This section is effective for reports submitted after June 30, 2025.

Sec. 2. Minnesota Statutes 2024, section 121A.041, subdivision 3, is amended to read:

Subd. 3. Exemption. A public school may seek an exemption to subdivision 2 by submitting a request in writing to all 11 federally recognized Tribal Nations in Minnesota and to the Tribal Nations Education Committee by September 1, 2023. The exemption is denied if any of the 11 Tribal Nations or the Tribal Nations Education Committee oppose the exemption by December 15, 2023 requesting a letter of consent from the Tribal Nation located nearest to the public school. A public school whose request for an exemption consent from a Tribal Nation is denied must comply with subdivision 2 by September 1, 2026.

EFFECTIVE DATE. This section is effective the day following final enactment.

# Sec. 3. APPROPRIATION; MASCOT REPLACEMENT ASSISTANCE.

Subdivision 1. **Department of Education.** The sum indicated in this section is appropriated from the general fund to the Department of Education in the fiscal year designated.

Subd. 2. Mascot replacement assistance. (a) For assistance to public schools seeking to comply with Minnesota Statutes, section 121A.041:

<u>\$</u> ..... <u>2026</u>

(b) The commissioner of education must establish a process for a public school to apply to the commissioner for reimbursement of costs incurred to meet the requirements of Minnesota Statutes, section 121A.041, subdivision 2, including the costs of replacing a prohibited name, symbol, or image on uniforms, signs, paintings, equipment, gym floors, websites, and other school property, including supplies and other building surfaces. The application must be in the form and manner determined by the commissioner.

(c) For costs incurred after June 30, 2024, but before July 1, 2025, the commissioner may reimburse up to 100 percent of the public school's costs.

(d) For costs incurred after June 30, 2025, the costs must be included in a work plan and budget submitted by the public school to the commissioner and approved by the commissioner to be eligible for reimbursement. The commissioner may reimburse up to 100 percent of the costs under this paragraph.

(e) This is a onetime appropriation and is available until June 30, 2027."

Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have the meanings given.

(b) "Agricultural assets" means agricultural land, livestock, facilities, buildings, and machinery used for farming in Minnesota.

(c) "Beginning farmer" means an individual who:

(1) is a resident of Minnesota;

(2) is seeking entry, or has entered within the last ten years, into farming;

(3) intends to farm land located within the state borders of Minnesota;

(4) except as provided in subdivision 2, paragraph (f), is not and whose spouse is not a family member of the owner of the agricultural assets from whom the beginning farmer is seeking to purchase or rent agricultural assets;

(5) except as provided in subdivision 2, paragraph (f), is not and whose spouse is not a family member of a partner, member, shareholder, or trustee of the owner of agricultural assets from whom the beginning farmer is seeking to purchase or rent agricultural assets; and

(6) meets the following eligibility requirements as determined by the authority:

(i) has a net worth that does not exceed the limit provided under section 41B.03, subdivision 3, paragraph (a), clause (2);

(ii) provides the majority of the day-to-day physical labor and management of the farm;

(iii) has, by the judgment of the authority, adequate farming experience or demonstrates knowledge in the type of farming for which the beginning farmer seeks assistance from the authority;

(iv) demonstrates to the authority a profit potential by submitting projected earnings statements;

(v) asserts to the satisfaction of the authority that farming will be a significant source of income for the beginning farmer;

(vi) is enrolled in or has completed within ten years of their first year of farming a financial management program approved by the authority or the commissioner of agriculture;

(vii) agrees to notify the authority if the beginning farmer no longer meets the eligibility requirements within the three-year certification period, in which case the beginning farmer is no longer eligible for credits under this section; and

(viii) has other qualifications as specified by the authority.

(d) "Emerging farmer" means an emerging farmer within the meaning of section 17.055, subdivision 1.

(e) (d) "Family member" means a family member within the meaning of the Internal Revenue Code, section 267(c)(4).

(f) (e) "Farm product" means plants and animals useful to humans and includes, but is not limited to, forage and sod crops, oilseeds, grain and feed crops, dairy and dairy products, poultry and poultry products, livestock, fruits, and vegetables.

(g)(f) "Farming" means the active use, management, and operation of real and personal property for the production of a farm product.

(g) "Limited land access farmer" means a farmer experiencing limited land access as defined in section 17.133, subdivision 1.

(h) "Owner of agricultural assets" means an individual, trust, or pass-through entity that is the owner in fee of agricultural land or has legal title to any other agricultural asset. Owner of agricultural assets does not mean an equipment dealer, livestock dealer defined in section 17A.03, subdivision 7, or comparable entity that is engaged in the business of selling agricultural assets for profit and that is not engaged in farming as its primary business activity. An owner of agricultural assets approved and certified by the authority under subdivision 4 must notify the authority if the owner no longer meets the definition in this paragraph within the three year certification period and is then no longer eligible for credits under this section.

(i) "Resident" has the meaning given in section 290.01, subdivision 7.

(j) "Share rent agreement" means a rental agreement in which the principal consideration given to the owner of agricultural assets is a predetermined portion of the production of farm products produced from the rented agricultural assets and which provides for sharing production costs or risk of loss, or both.

**EFFECTIVE DATE.** This section is effective for taxable years beginning after December 31, 2024."

(1) the number and amount of credits issued;

(2) the geographic distribution of credits;

(3) a listing and description of each approved financial management program for which credits were issued; and

(4) a description of the approval procedure for financial management programs not on the list maintained by the authority, as provided in subdivision 3, paragraph (a).

**EFFECTIVE DATE.** This section is effective for reports due for credits issued for taxable years beginning after December 31, 2024."
